

NWPS Areas designated since the Colorado Wilderness Act of 1980 (PL 96-560)
Incorporating special language on grazing management

update 8/26/2009

Of the 88 laws (or titles) passed since the Colorado Wilderness Act of 1980 (to which was attached the Congressional Grazing Guidelines) 34 designated areas are believed to have authorized grazing. Of these, 26 laws (76%) refer to the Congressional Grazing Guidelines (in one of its variations). Six (18%) are either silent on grazing or include language which is merely a re-write on the 1964 Act. Two early laws, signed in 1983 and 1984, have special grazing language which allowed motorized use that seems either to be consistent with the Congressional Grazing Guidelines or conflated with inholding access. (Three laws which cite the CGG have additional special language allowing (or mandating) retirement of grazing allotments.)

NOTES:

When one Act is cited more than once, the wildernesses designated are segregated by agency in different Titles (with different management prescriptions). When multiple agencies are listed under one Act, the various wilderness areas designated are under the same set of management prescriptions.

In the *grazing?* column:

Y = there was grazing in this wilderness at the time of designation.

N = there was no known authorized grazing at the time of designation

? = the status of grazing at the time of designation is unknown

In the *reference* column:

96-617 = a reference to this House Report, another version (with no substantive differences) of HR 96-1126

96-1126 = a reference to this House Report (known as the Congressional Grazing Guidelines (CGG); usually references as "Sec. 108 of P.L. 96-560" which in turn references the H.R. 96-1126 attached to that law.

101-405A = a reference to this House Report attached to P.L. 101-628; this essentially re-writes H.R. 96-1126.

Special = grazing management guidelines included which are not a reference to either of the above House Reports.

¹ motors allowed for "activities associated with existing levels" of grazing

² motors allowed in Carson-Iceberg; and Ansel Adams (San Joaquin) for access to facilities for "permitted livestock grazing activities" in "same manner and degree" as was "occurring" at enactment
